Other Site Characteristics

Poco a sud di Rovereto il fondovalle in sinistra Adige è occupato dai blocchi calcarei (marocca) di antiche frane, coperti da una stentata vegetazione prevalentemente arbustiva; nelle ondulazioni dell'ammasso di detriti fanno spicco due laghetti con un'apprezzabile vegetazione paludicola. con scomparsa delle piante paludicole a favore di banali specie legnose.

4.2 Quality and importance

Di particolare pregio è la flora dei due laghetti: in tempi successivi vi sono state rinvenute un gran numero di entità decisamente rare a livello regionale e nazionale. Si tratta di un biotopo di vitale importanza per la riproduzione di molte specie di anfibi e rettili.
