4.2 Quality and importance

Nucleo residuo, di grande interesse per la tipologia, di boschi di caducifoglie mesofile del piano collinare, in via di regressione in tutta la fascia prealpina. Il sito è di rilevante interesse nazionale e/o provinciale per la presenza e la riproduzione di specie animali in via di estinzione, importanti relitti glaciali, esclusive e/o tipiche delle Alpi. Presenza di specie di coleotteri legati a boschi maturi di latifoglie della fascia basale.
